Other – Alma reported on the new credentialing equipment received under the North Central Planning, Exercise, Training Region Grant which includes Region 26. There will be training next week on the Track App and are welcome to come, however our plan is to become well versed in the program so that we can train our local people.

The only event that is coming up will be the Junk Jaunt. Ashley Jeffres mentioned that the Valley County Health System Foundation is sponsoring a 50 mike walk/run/bike event the Saturday of Junk Jaunt. It was also mentioned they may be trying to move the date. We will watch for any further information.
