 - Ben Young reported on the exercise they held with a weather-related event on September 19th. The following agencies were involved. Had 12-14 victims, had decontamination station, tested the generators with power going off. It was a good exercise.
 - b. Sandbags have been passed out due to flooding to Burwell, Ord, Loup City and North Loup. There is a need for more to restock the supply.
- 4) New Business
 - a. TRIMRS Presentation Catie Larsen handed out a map along with a list of hospitals and nursing homes. They have two trailers with medical supplies that can be moved from one location to another. She also included a list of what we would call TRIMRS for and the days and times they can be reached along with an urgent need number. Cody Samuelson is the coordinator for TRIMRS. Catie can also be reached at the Loup Basin Public Health in Burwell for assistance.
- 5) Flood Recovery There are people that may need assistance in our towns and counties that we may not be aware of. They may need help working on grants for projects. What things can be worked on ahead of time for preparation for other disasters. Would be beneficial to develop a long-term recovery committee but hard to do especially with monetary donations because of how they have to be handled. Monetary donations and having a 501C3 organization that would be willing to accept funds. Then the problem is how will the funds be dispersed and who would make that decision. If anyone knows an organization that would be willing to do that in your county let us know.
